## ***New Date for Food and Film Night***



Our next food-and-film evening will be on Sunday, May 20, at 5:30 PM, a change of date from the earlier announcements. The film is the comedy-drama *The Women's Balcony*. This Israeli film centers on the members of a small, modern Orthodox, Sephardic congregation in Jerusalem. During a bar mitzvah, the women's balcony collapses, leaving the elderly rabbi in shock. The charismatic young rabbi who steps forward to provide leadership turns out to be ultra-Orthodox. Fractures along gender lines ensue before a happy resolution.

The *New York Times* describes the film as “a charming exercise in gender politics as experienced via religion.” Another source describes it as a “rousing, good-hearted tale about women speaking truth to patriarchal power.”

While we are an egalitarian congregation, with women rabbis, the sense of community in a small congregation will be familiar as will numerous scenes, including one about who has brought what to a potluck dinner.

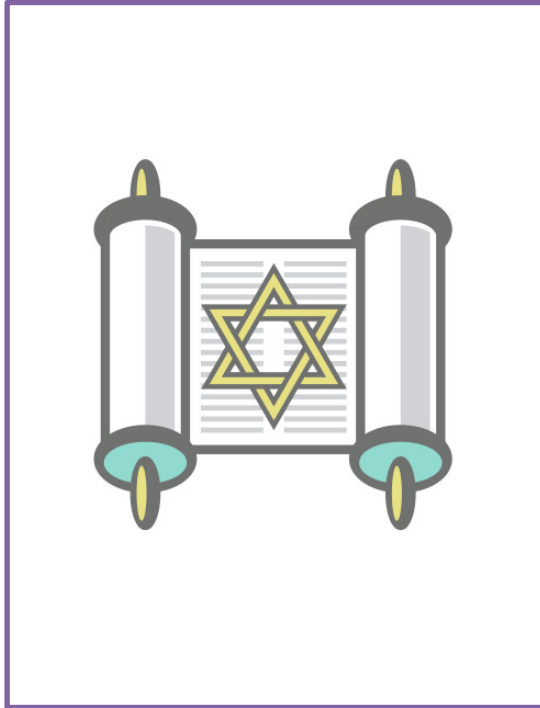

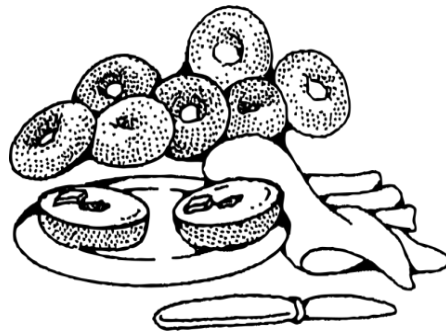
## ***Passover Recap***

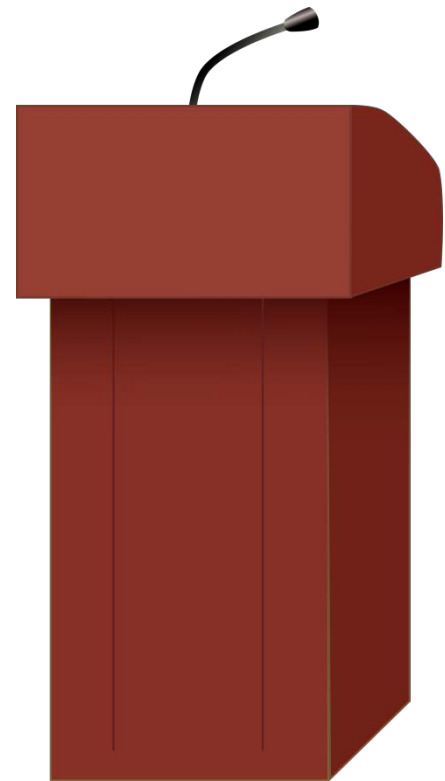
## ***Chatter***

# Congregation Beth Shalom

## Proposed Budget 2018-2019 Narrative

The proposed budget for Congregation Beth Shalom for the 2018-2019 operational year (July 1, 2018 through June 30, 2019) is presented on the next pages. This narrative describes the budget figures and discusses their development.

### Overview of Budget and Fund Statements

The Budget Proposal separates anticipated revenue (income) sources from anticipated expense items. For comparison, the first column shows the approved budget from 2017-2018; the second column shows the actual income/expense as of April 15, 2018; the third column shows the projected income/expense anticipated to occur by the end of the fiscal year (June 30, 2018); and the fourth column shows the variance—over or under—that is projected to result. The fifth column shows the proposed budget figures for 2018-2019, with brief notes at the right as short explanations for differences and changes from the prior year.

For additional reference, the Fund Summary Report shows the Congregation's total cash and investment holdings. The Congregation's resources are divided into eleven different Funds (Building, Cemetery, General, etc.). The values in each fund are then invested in checking, savings, or various trust investment accounts depending on the total resources available and anticipated expenditures (overall and by Fund) in each given year. These investments and earnings are reported to and reviewed by the CBS Board of Directors at each monthly meeting, with the Treasurer and the CBS Trust Banker undertaking more in-depth reviews every three to six months. The first column of the Fund Summary Report shows the balances beginning at the start of the 2017-2018 budget year; the second column shows the balances as of March 31, 2018; and the third column details the gains or losses as of that date.

### Anticipated Revenue

Overall, Congregation Beth Shalom is in a good financial position. As of March 31, 2018, we have just over three-quarters of a million dollars in cash, savings, and investments, with expenditures running just over \$57,000 per year. It is anticipated that in 2018-2019, we will generate approximately \$39,000 in Dues (General Fund) income and another \$14,000 in Donations (other funds). While *almost* sufficient to cover expenses as incurred in prior years, this amount still represents a decline in both Dues and Donations. Existing members continue to be very generous in their giving to the Congregation, but there are just fewer member families belonging to Beth Shalom each year. Despite the best efforts of the Board to hold expenditures to only the necessary levels, it will still be required during this coming year—as it has been for the past several years—to withdraw earnings from savings and investments to pay the bills.



## **Expenses**

Expenses for 2018-2019 are expected to remain similar to that from 2017-2018 with two exceptions. The first is in regard to Buildings and Grounds. During the coming year, the building roof will need to be replaced, and the parking lot will need to be sealed and striped. Although formal bids for this work have not yet been solicited, the Board is anticipating an additional \$12,000 for this work to be done.

The second exception is due to the unfortunate passing of Rabbi Moskow, which necessitates that we conduct a search for a new Rabbi. We anticipate that the search will take part of the fiscal year to accomplish, with additional expenses needed for recruitment and advertising. Current salaries for a half-time Rabbi for congregations of our size are in the \$40,000 to \$60,000 range; since we anticipate hiring for just a portion of the year, only half of that anticipated salary (\$25,000) is included in the 2018-2019 budget. Not having a Rabbi on salary will, however, increase the cost for High Holy Days as we will need to pay a temporary Rabbi, in addition to our usual Cantor, to serve the Congregation during the holidays.

These expense figures represent the Board's best estimate at this moment in time. The search for a new Rabbi may happen more quickly or take much longer than anticipated, which will change both the expected temporary costs and the budgeted Rabbi costs for 2018-2019. The Board is also committed to hiring a true half-time Rabbi with the energy, vision, and drive to significantly increase new member recruitment and retention, assist with the creation of new programming for all our members, and reinvigorate our Religious School. These desired duties and the time commitment to accomplish them could command a higher salary than the Congregation has been accustomed to pay in the past. As a result, this budget, perhaps more than others in the recent past, must be considered as somewhat fluid given the uncertain nature of the Rabbi search to be undertaken.

## **Summary**

The current budget proposal for 2018-2019 represents anticipated expenditures of approximately \$63,750, an increase of \$5,800 over the budgeted expenditures for 2017-2018. With anticipated revenues of \$54,950, a total of approximately \$8,800 will need to be drawn from savings and/or investments in order to balance the budget and pay anticipated bills. The Congregation has more than sufficient holdings to cover such a drawdown for this budget year (and for several years into the future, should the need continue). The repairs to the roof and parking lot are necessary, and their further delay will only result in additional cost to the Congregation in the future. The longer-term increase in expense—the hiring of a true half-time Rabbi with commensurate pay—could further contribute to higher expenses in the future if the goals of increased membership are not realized over time. It is the Board's opinion, however, that the recruitment and hiring of a true half-time Rabbi with the skills and drive to reinvigorate the Congregation with new and expanded programming, to reimagine and expand our Religious School, and to seek out and encourage new members is necessary for the Congregation to thrive long-term. It is our recommendation, therefore, that the proposed budget for 2018-2019 be accepted.
